Re: Use of Seasonally Maintained Public Roads during the winter months

Please find enclosed (on the other side of this document) a list of local public roads which are not opened and therefore are not maintained or serviced during the time period of November 1st to April 30th by the Municipality. Any travel upon these roads during this time period is at the individual's own risk, whether they are the property owner, a guest of the property owner or otherwise third party.

If you choose to have the road maintained in the winter including snow plowing, salting, sanding etc. then you should ensure that;

- a) if you are doing this work yourself that you have the necessary liability insurance in place in the event of damage to the road, injury or death, to any party as a result of servicing the road.
- b) If you have chosen to contract this service out to a contractor you should ensure that the contractor is a licensed and a bonded contractor who has the necessary liability insurance in place in the event of damage to the road, injury or death, either directly to the contractor or its employees or to any other party as a result of their servicing the road.
- c) Maintenance will not be allowed on any road where winter use has been granted to the Sno Mobile Club.

Please be advised that the municipalities' insurance coverage will not apply to the listed roads during the time period stated and therefore no claim may be brought against the Municipality for any reimbursement in the event of any injury or death of person or property.

If a legal action or suit is brought against the Municipality as a result of any servicing or maintenance of the road by you or with your consent during the time periods stated then the Municipality will seek to be held harmless and seek full indemnity from you for any costs, damages, awards including any legal costs on a substantial indemnity basis incurred by the Municipality as a result of your use of the road during the time period stated, your servicing or maintenance of the road or your consent whether expressed or implied to any third party to use, service or maintain the road during this time period.

If you do intend to use your property during the winter months as listed it is entirely up to you to ensure that emergency vehicles can access your property during this time period and the Municipality makes no representations or warranties as to the pass-ability, safety, condition, or fitness of the roads listed herein during the time period stated herein.
