B. Koehler, Councillor and Chair of the Tri-Neighbours Board indicated that the Engineering Report from AECOM regarding the Abattoir's request is in draft form and will be shared once complete.

K. Hoback submitted/read a letter (Oct. 21st) for Council's consideration:

Madame Mayor and councillors

I agree whole heartily Plummer Additional and Bruce Mines will benefit from the creation of the work spaces at the proposed slaughter house on Hwy 17. Creation of 15 full time would be better but it is improving our lot.

The points I raise tonight are to ensure the process which is underway as outlined by Ms Brunke with the Ministry of the Environment, Ontario Ministry of Agriculture, Food and Rural Affairs and perhaps Ministry of Natural Resources will ensure the continued enjoyment of our idyllic place of residence, provide continued clean water to drink, swim and enjoy fish from.

What information I have tonight is gleaned from several sources on the internet, namely research papers from PhD students, rules for slaughter houses, potential issues as regards management of Slaughterhouse Waste Water and the non-marketable component of the activity.

The information requested for Plummer Additional Township

Water required is up to 1400 litre per large animal carcass.

40 animals a week = 56000 litre a week. I understand there is an assessment process to provide potable water from the Bruce Mines water system to the new facility.

1. Will the Bruce Mines water system be able to supply the existing needs and this extra volume and not compromise fire suppression in the Bruce Station area?
2. To where will the slaughterhouse wastewater be directed?
3. As has been reported in the literature the wastewater contains biological hazards. What will be the pre-treatment to the slaughterhouse wastewater?
4. What is the intended mode of disposition of the waste solids?
5. Will the existing facilities accommodate this volume of waste and what will be the long-term effects of this deposition?
6. Should the blood be sent to the lagoon how long will the blood need to be in the lagoon to be safe for the lagoon to be drawn down?
7. What is the cycle for drawdown on the lagoon?
8. Where does the drawdown water go?
9. What odour control will be in place?
10. What solid animal waste (if any) will be placed in the Rose township landfill?
11. Should animal waste be placed at the Rose Lake facility what animal control measures will be put in place to address the influx of predators?
12. What is the buffer radius from the slaughterhouse or other place wastes will be disposed for direct consultation with residents of Plummer Additional?

Put forward as a motion to the Municipality of Bruce Mines as items of concern from Plummer Additional ratepayers.

- Questions posed will be copied to the Tri-Neighbours Board for consideration.

AND WHEREAS Municipal, Provincial and Federal Governments as well as healthcare, education and other sectors will continue to depend on the internet to communicate, provide services and ensure accessibility to information;

AND WHEREAS digital literacy skills are essential to collaborate, innovate, and compete both regionally and globally and require appropriate and affordable broadband;

AND WHEREAS the availability of broadband that is on par with larger, urban areas in Canada is essential for Northern Ontario to achieve economic sustainability and social well-being;

AND WHEREAS in 2016 the Federation of Northern Ontario Municipalities (FONOM) requested that the internet be designated as an essential service and that efforts are undertaken to ensure all municipalities have access to affordable, fast, and reliable broadband;

AND WHEREAS the Federation of Northern Ontario Municipalities (FONOM) agreed that an option to explore and hopefully support would be the Starlink Program, by SpaceX;

THEREFORE BE IT RESOLVED THAT the Township of Plummer Additional agrees that that Broadband is an essential service, and that the Canadian Radio-television and Telecommunications Commission (CRTC) should allow SpaceX and

other private ventures to compete with those presently acting in the communication field, as they have the private financial ability to move forward;

d) Tarbutt Northern Ontario Agriculture

WHEREAS per Tarbutt Township, the farming industry in Ontario has become increasingly threatened with the growth of industry and Urban sprawl; and

WHEREAS as according to Ontario Farmland Trust, Ontario continues to lose 175 acres of farmland daily; and

WHEREAS between 1976 and 2016 Ontario lost 20% of its farmland; and

WHEREAS this loss of land is some of the most productive land in the province and such loss is unsustainable; and

WHEREAS Ontario's agri-food sector is the largest economic sector in the province, employing more than 820,000 Ontarians along the supply chain and annually contributing over \$39 billion to the province's GDP (Gross Domestic Product); and

WHEREAS In rural areas, the agri-food sector is even more important, as roughly 12% of the GDP and 10% of rural jobs are associated with agriculture; and

WHEREAS Agricultural land is the base of the agri-food sector, and it is a finite resource with only 0.5% of Canada's agricultural soil is classified as Class 1, and about half of the entire country's Class 1 soil is found in Ontario; and

WHEREAS most of the lost agriculture land is in southern Ontario; and

WHEREAS northern Ontario has seen an unprecedented growth in agriculture in recent years; and

WHEREAS northern Ontario is well on its way to being the future breadbasket for Ontario; and

WHEREAS the growth in northern Ontario agriculture is virtually unsupported by Federal and Provincial funding, yet all benefit from the growth in agriculture in northern Ontario; and

WHEREAS to continue to shoulder the burden of feeding the province and growing the agriculture sector in northern Ontario, certain infrastructures and financing opportunities need to be in place; and

WHEREAS the agriculture sector has seen a constant decrease in the availability of farm workers;

THEREFORE the Council of Plummer Additional supports Tarbutt Township in their request that significant steps be taken to provide Broadband service to all of northern Ontario to permit the use of technological advancements such as Robotic Milkers for dairy farmers in the absence of finding and retaining farm help, and

FURTHER that appropriate funding to match the crisis that the decline in agriculture is facing be established for farmers and that such funding be sustainable to allow for planning and growth; and

FURTHER THAT this resolution be forward to the FONOM; the Minister of Energy, Northern Development and Mines; the Minister of Agriculture Food and Rural Affairs; Minister of Infrastructure; Innovation, Science and Economic Development Canada; Central Algoma Municipalities and Huron North Community Economic Alliance. CARRIED
